Tour Participation: Children under 18 years of age must be accompanied by an adult. 4. Tours with any air flights included in the price must be paid in full **60 DAYS** before the tour departs.
5. Your agents will, on the receipt of any monies, hold such monies for each and every person named in the booking until the booking is confirmed at which times those monies will be remitted promptly by your agent to Fairy Chimneys Travel. All such monies received by Fairy Chimneys will be deposited as required by law. We will be entitled to keep for each account any interest earned on such monies. Booking Changes:

A fee of \$50 per person will be charged for any revision or alteration made to a reservation after the booking is confirmed unless the change is to a more expensive tour.

Cancellation and Cancellation Fees:

- A \$100 fee per person per tour will be charged for all cancellations.
